It is designed so that we, the Youth Leadership Team (YLT) can act and make decisions on your behalf just in case something happens.

Permission Statement: Unless I / we contact the YLT to state otherwise, I / we do give our permission and consent for our son / daughter to participate in any / all events / activities sponsored by Grandville Bible Church.

I / we also agree that the YLT has the right to exclude my son / daughter from participation as long as they provide **both student and parent(s) / guardian(s)** with the reason(s) why this decision was made.

Medical Release Statement: If my son / daughter requires medical attention (minor, major, emergency) and I / we cannot be reached for whatever reason, I / we give permission to the persons or facility providing medical care to provide treatment, to hospitalize, to order and perform medical testing and care as believed necessary (i.e.- x-rays, injections, anesthesia, surgery, etc.) The YLT is also authorized to perform, provide, or delegate first-aid care to the best of their ability on behalf of my / our student.

I agree that professional medical attention will be sought if either my son / daughter or the YLT believes the injury / illness requires such attention. I realize that medical options / specialists may be limited to factors beyond the YLT's control.

It is understood and agreed upon that any insurance available from Grandville Bible Church will only be secondary insurance. If I / we have insurance(s), our carrier(s) will be primarily responsible and will be billed for related costs. If I / we do not have adequate insurance coverage, arrangements to satisfy any financial obligations my / our student may acquire will be cared for by me / us.

Liability Release Statement: I / we understand that every activity sponsored by Grandville Bible Church is carefully planned and adequately supervised by mature and responsible adult leaders (YLT). However, I / we also agree that even with the best of planning and precaution, unforeseen things may occur. Along with our student, I / we agree to assume and accept all risks and hazards inherent in any / all church-related events. I / we also agree not to hold Grandville Bible Church, it's pastoral staff, employees, leadership, and volunteer staff and sponsors liable for damages, losses, injury, illness to persons or property in regard to my /student and our family / business.

Temporary Power of Attorney Statement: I / we the parent(s) / legal guardian(s) of the student named on this form delegate to the YLT of Grandville Bible Church a temporary power of attorney so that in my / our absence they can have custody and make necessary decisions on my / our student's behalf. I / we will support and agree to the decisions made for my / our student by the YLT.
